WHEREAS, the Brown County Board of Commissioners ("Board") desires to encourage the development of alternative energy generation facilities; and

WHEREAS, developers of alternative energy generation facilities have expressed interest in constructing energy projects in Brown County, provided that the appropriate incentives are in place to support the economic performance of the projects; and

WHEREAS, the Board is willing to provide real and tangible personal property tax exemptions to support the development of alternative energy generation facilities, conditional upon the appropriate service payments are made pursuant to O.R.C. 5727.75(G); and

WHEREAS, pursuant to O.R. C. 5727.75(E), the Board can declare Brown County to be an Alternative Energy Zone.

THEREFORE, BE IT RESOLVED: by the Board of Commissioners of Brown County, Ohio, that on the above findings, that:

Section 1: The Board declares Brown County to be an Alternative Energy Zone pursuant to R.C. 5727.75(E)(1)(c).

Section 2: The Board declares that all applications for property tax exemption submitted by the Director of Developments (the "Director") pursuant to R.C. 5727.75(E) after the adoption of this resolution, and prior to its repeal, are approved.

Section 3: The approval provided in Section of this Resolution is expressly conditioned upon the payment of an annual service payment in addition to the annual service payment required under R.C. 5727.75(G).

- A. The amount of each annual service payment shall be the difference between \$9,000.00 and the payment required and made under O.R.C. 5727.75 (G) per megawatt multiplied by the nameplate capacity in megawatts of the energy project in Brown County, Ohio.
- B. The annual service payment required by this Resolution shall be paid on or before the final dates for payment of taxes on public utility personal property on the real and public utility personal property tax list for each tax years for which the property of the energy project is exempt from taxation pursuant to O.R.C. 5727.75.
- C. The annual service payment required by this Resolution shall be paid by the owner of the energy project, or by the lessee of the project pursuant to a sale and leaseback transaction.
- D. The Brown County Treasurer is directed to deposit the annual service payments required by this Resolution into the general operating fund of the county.

Both of the payments required pursuant to O.R.C. 5727.75 (G) and authorized pursuant to O.R.C. 5727.755 (E)(1)(b) shall be charged and collected at the same time and in the same manner as the taxes imposed on taxable property subject to assessment under O.R.C. 5727.

Section 4. The clerk is directed to send a copy of this Resolution by certified mail to the Director and owner of each energy project that is the subject of a permit from FERC, OPSB and/or any other approved applications or permits from the State of Ohio submitted by the Director or owner of each energy project to the Board of Commissioners within 30 days after the request is received by the Board. The clerk shall also provide a copy of this Resolution to the Brown County Treasurer within 30 days after the resolution is passed; as well as, copies of any approved applications or permits received from any director of potential developments received by the Board of Commissioners.

Section 5. This Board finds and determined that all formal actions of this Board and any of its committees concerning and relating to the adoption of this Resolution were taken, and that all deliberations of the Board and of any of its committees that resulted in those formal actions were held, in meetings open to the public in compliance with the law including Section 121.22 of the Ohio Revised Code.
