WHEREAS, it is determined by the Brown County Auditor and the Board of County Commissioners that it is

necessary to establish a special revenue fund pursuant to Section 5705.09(F) of the Revised Code; and

WHEREAS, Brown County is a Local Government that has adopted and approved the OneOhio Memorandum of

Understanding (the "Memorandum"), which establishes a mechanism to disburse settlement proceeds from the opioid

litigation into Ohio's communities to help abate the opioid crisis, and

WHEREAS, pursuant to the terms of the Memorandum, 30% of the settlement proceeds will be paid directly to

local governments, including Brown County, for approved purposes as delineated by the Memorandum, and

THEREFORE, BE IT RESOLVED: that the Board of County Commissioners, in and for Brown County, Ohio

hereby authorizes the Brown County Auditor to establish a fund and with revenue and expense accounts for the account

described above based on the recommendation of the Brown County Auditor and as approved by the Memorandum.
