The following resolution was presented by Mr. Woodruff, who moved its adoption, and seconded by Mr. Applegate.

WHEREAS, Brown County Agricultural Society was organized on January 17, 1850 and the fair was first held in Russellville, Ohio in 1850; the second fair was held in Ripley on in 1851 and then in 1853 the fair was moved to Georgetown and remains there today; and

WHEREAS, the Brown County Fair promotes agriculture, education, entertainment, and encouraging positive youth development, leadership skills, and tourism; and

WHEREAS, by 1926 it was heralded as the "Little State Fair": and

WHEREAS, the pandemic created particularly deleterious effects on Brown County residents, farmers and visitors attending the fair with social isolation and financial situations due to COVID; and

WHEREAS, Brown County 4-H program is one of the largest in the state, and our young people are very dedicated to their projects and a big asset to the Fair with many volunteers. Annually there is typically more than 110,000 visitors and judges from across the USA, which is the largest tourist attraction in Brown County drawing exhibitors, vendors, and attendees from all over the state, with participation by 1,500 including 4-H, FFA, and other organizations; and

WHEREAS, this grant will provide Brown County Fair as a continued tourist attraction and expansion to year-round offerings with Fairground Improvements, while offering additional resources to support core mission of youth engagement, education, and leadership. Secures an asset in the county and region, while providing necessary updates to ensure fairs and new attractions. Stabilizes revenue stream by eliminating total reliance on fair week.

NOW THEREFORE, BE IT RESOLVED that the Brown County Board of Commissioners does hereby authorize a grant to the Brown County Fair Board in the amount of \$50,000.00 to put toward the organization's goals and objectives, for the purpose of serving Brown County residents.
