PURCHASE OF LAND, CONSTRUCTION OF BUILDING AND CONVEYANCE OF REAL PROPERTY TO BROWN COUNTY BOARD OF DEVELOPMENTAL DISABILITIES

The Board of County Commissioners of Brown County, Ohio, met on the 19th day of April, 2023, in regular session at the offices of said Board in the Administration Building, Georgetown, Ohio, with the following members present:

Barry Woodruff, President Tony Applegate, Member

The following resolution was presented by <u>Applegate</u>, who moved its adoption, and seconded by <u>Usedauff</u>.

WHEREAS, the Brown County Board of Developmental Disabilities desires to purchase certain real property consisting of 19.07 acres and more commonly known as Parcel No. 33-061972.0000 in Brown County, Ohio (the "Property") for the construction of a new Resource and Community Center Building (the "Project").

WHEREAS, the Brown County Board of Developmental Disabilities has sufficient unencumbered funds to purchase the Property and construction materials and to pay for necessary architect, contractor and other professional fees related to the construction of the Project.

WHEREAS, the Brown County Board of Commissioners has the power to transfer to the Brown County Board of Developmental Disabilities real property in fee simple belonging to

Brown County and not needed for public use by Brown County upon the terms and in the manner that it may determine to be in the best interests of Brown County, without advertising for bids.

WHEREAS, the Brown County Board of Commissioners is willing to facilitate the goal of the Brown County Board of Developmental Disabilities in furtherance of the Project to purchase real estate for purposes of constructing a building to meet the needs of the Brown County Board of Developmental Disabilities.

WHEREAS, the Brown County Board of Commissioners hereby determines it in the best interest of Brown County to facilitate the purchase of land and construction of a building to meet the needs of the Brown County Board of Developmental Disabilities.

THEREFORE, BE IT RESOLVED: by the Board of Commissioners of Brown County, Ohio, that, on the above findings:

1. The Brown County Board of Commissioners hereby designate the Brown County Board of Developmental Disabilities to act as a designee of the Brown County Board of Commissioners and hereby authorize the Brown County Board of Developmental Disabilities to take all appropriate and lawful actions to complete the Project, including, but not limited to, entering into a real estate purchase contract on terms deemed reasonable by the Brown County Board of Developmental Disabilities, securing the purchase of real estate, and pursing to completion the construction of a building in accordance with Ohio law, as if such actions were taken by the Brown County Board of Commissioners.

 All costs, fees, expenses, and charges related to the Project, including but not limited to the purchase of the real estate and the construction of the building, shall be paid for by the Brown County Board of Developmental Disabilities out of its general fund or capital fund, or

both, as applicable. The Brown County Board of Commissioners shall have no obligation to pay, and shall not pay, for any costs, fees, expenses, and charges related to the purchase of the real estate and the construction of the building on behalf of the Brown County Board of Developmental Disabilities.

3. In accordance with Resolution No. 1, above, the Brown County Board of Developmental Disabilities shall engage the services of an architect, project manager, or other appropriate professional to oversee the completion of the Project and the construction of the building and shall be responsible for any costs, expenses or fees related thereto. The Brown County Board of Commissioners shall have no obligation to pay, and shall not pay, for any costs, fees, expenses, and charges related to oversight of the Project.

4. Upon completion of the Project, and once the new building has been approved for occupancy and is otherwise in accordance with any applicable building code, the Brown County Board of Commissioners shall execute a deed, transferring the real estate and building to the Brown County Board of Developmental Disabilities in fee simple. The Brown County Board of Developmental Disabilities is responsible for having the appropriate deed prepared by the Brown County Prosecuting Attorney or other legal counsel. 5. The Brown County Board of Commissioners hereby ratify, adopt and confirm the actions heretofore taken by the Brown County Board of Developmental Disabilities and its

agents in furtherance of the Project.
