RESOLUTION NO. 03252024-1 NECESSITY FOR LEVYING TAX EXCEEDING TEN-MILL LIMITATION

The Board of Commissioners, Brown County, Ohio, met in regular session on the 25th day of March, 2024, at the office of said Board, with the following members present:

Tony Applegate Daryll R. Gray

Mr. Applegate moved the adoption of the following resolution:

WHEREAS, the amount of taxes which may be raised within the ten-mill limitation will be insufficient to provide an adequate amount for the necessary requirements of the Ohio State University Extension Programs for Brown County, Ohio; and

WHEREAS, pursuant to R.C. 5705.03, a resolution declaring the necessity of levying a tax upon the incorporated and unincorporated areas of Brown County under R.C. 5705.19(WW) outside the ten-mill limitation must be passed and certified to the county auditor of Brown County in order to permit the Board of Commissioners to consider the levy of such a tax and must request that the county auditor certify to the board of commissioners the total current taxable value of the incorporated and unincorporated areas of Brown County and the dollar amount of revenue that would be generated by the tax.

NOW THEREFORE BE IT RESOLVED by the Board of Commissioners, Brown County, Ohio, two-thirds of all members elected thereto concurring:

SECTION 1. That pursuant to R.C. 5705.19(WW), it is necessary to levy a tax, to constitute a tax in excess of the ten-mill limitation to provide revenue to the Ohio State University Extension, for the purpose of conducting educational activities related to agriculture, natural resources, community development, family and consumer sciences, and 4-H programs for the benefit of the citizens of Brown County, Ohio, at a rate not exceeding .25 mills for each \$1 of taxable value for a five-year period of time, covering tax years 2025, 2026, 2027, 2028, and 2029. Said levy is a renewal levy.

SECTION 2. The question of the passage of said tax levy shall be submitted to the electors of the incorporated and unincorporated areas of Brown County at an election to be held on November 5, 2024.

SECTION 3. If approved by the electors, said tax levy shall first be placed upon the 2025 tax list and duplicate, for first collection beginning January 2026.

SECTION 4. The clerk of this Board is hereby directed to certify a copy of the resolution to the county auditor and board of elections, Brown County, Ohio.

SECTION 5. Pursuant to R.C. 5705.03, the county auditor is hereby requested to certify to this Board of Commissioners the total current taxable value of the incorporated and unincorporated areas of Brown County and the dollar amount of revenue that would be generated by the tax levy if approved by the electors.

SECTION 6. It is found and determined that all formal actions of this Board of Commissioners concerning and relating to the adoption of this resolution were adopted in an open meeting of this Board, and that all deliberations of this Board, and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code, and the rules of this Board, adopted in accordance therewith.
