A RESOLUTION BY THE BROWN COUNTY BOARD OF COMMISSIONERS RECOGNIZING AND CELEBRATING THE 200th BIRTHDAY OF ULYSSES S. GRANT AND DECLARING THE YEAR 2022 THE YEAR OF GENERAL AND PRESIDENT ULYSSES S. GRANT

WHEREAS, Hiram Ulysses Grant was born in Point Pleasant, Clermont County, Ohio on April 27, 1822 to Jesse Root Grant and Hannah Simpson Grant; and

WHEREAS, in the fall of 1823, Ulysses, or "Lys" as he was called during his childhood, moved with his family to the Village of Georgetown, in Brown County, Ohio, and as such this place remained his home until 1839 when he left as a young man to attend the United States Military Academy in West Point, New York; and

WHEREAS, "Lys" grew up in Georgetown at the family home located at the corner of Main Cross Street (Grant Avenue) and Water Street, and Grant's boyhood home still remains today and is preserved and maintained by the Ulysses S. Grant Homestead Association in conjunction with the Ohio History Connection; and

WHEREAS, of the many places Grant lived throughout his life none were longer than his time spent residing in Georgetown, Brown County, Ohio, and as Grant proclaimed about Georgetown in his worldrenowned personal memoirs, "This place remained my home"; and

WHEREAS, Ulysses S. Grant is universally known as one of our country's greatest war heroes, who as Commanding General of the United States Army, successfully led the Union to victory against the Confederacy in the Civil War; and

WHEREAS, Ulysses S. Grant was twice elected to the Presidency of the United States of America, holding office from 1869 until 1877; and

WHEREAS, as our 18th President, Ulysses S. Grant, boldly advanced equal rights for all African-American citizens, which included advocating for the ratification of the Fifteenth Amendment to the United States Constitution, the creation of the United States Department of Justice, and the enactment of the Civil Rights Act of 1875; and

WHEREAS, at the time of Ulysses S. Grant's death, on July 23, 1885, in Mount McGregor, New York, he was considered as one the World's most preeminent and popular citizens; and

WHEREAS, the final resting place of Ulysses S. Grant, and his wife, Julia, is the General Grant National Memorial, located in New York City, which is the largest mausoleum in North America; and

Now, therefore, BE IT RESOLVED by the Board of Commissioners, Brown County, Ohio that Brown County shall appropriately recognize and celebrate the 200th Birthday of Ulysses S. Grant throughout the year of 2022 and particularly on April 27, 2022; and additionally designate 2022 as the year of General and President Ulysses S. Grant.
