Brown County is certifying to the State of Ohio, that the county and Ralph Jennings, in his official capacity as Chairman of the Brown County Board of Commissioners, consent to accept the jurisdiction of Federal courts if an action is brought to enforce responsibilities in relation to environmental reviews, decision-making, and action; and that these responsibilities have been satisfied.
