EMERGENCY REPAIRS FOR THE COURTHOUSE O.R.C. §307.86(A)(2)

The Beard of County Commissioners of Brown County ("Board"), Ohio, met in regular session on the 12th day of September, 2011, at the office of said Board in the Administration Building, Georgetown, Ohio, with the following members present:

The following resolution was presented by Mr. Geschwind, who moved its adoption, and

WHEREAS, the Board owns certain real property commonly known as the Brown County

Courthouse ("Courthouse"), at 101 South Main St., Georgetown, Ohio and are charged by law

with the maintenance and upkeep of all county owned property;

WHEREAS, the Board finds the Courthouse to be a publicly accessed building presently used to

house essential county offices, such as the Common Pleas Court and the Clerk of Courts;

WHEREAS, the Board finds the Courthouse roof, gutter system and clock tower to be in such a state of disrepair that it leaks water uncontrollably;

WHEREAS, the Board finds the excessive rainfall has caused deterioration and water damage to such extent as to create a serious risk of failure of the structural integrity of the Courthouse, and further finds such deterioration is an actual physical disaster to the Courthouse;

WHEREAS, the Board finds that due to the ongoing nature of the deterioration and damage to the Courthouse, a real and present emergency exists and repairs to the Courthouse must be made immediately;

WHEREAS, Ohio Revised Code § 307.86(A) provides in relevant part: "...competitive bidding is not required when any of the following applies: * * * (2) There is actual physical disaster to structures * * *."

THUREFORE, BE IT RESOLVED, by the Board of Commissioners of Brown County, Ohio, and pursuant to O.R.C. § 307.86(A)(2), to enter into a contract, without competitive bids, with a qualified contractor to make the emergency repairs as needed to the Courthouse.
