Urging the Members of the United States House of Representatives and the United State Senate to Continue to Fund the United States Department of Housing and Urban Development (HUD) Community Development Block Grant Program (CDBG) and the Home Investment Partnership Program (HOME) at a Sustainable Level Necessary to Complete and Continue the Community Housing Improvement and Community Investment Strategies Developed for Every Small City and Entitlement City in the United States of America

WHEREAS, in 1982, President Ronald Reagan delegated the responsibility of administering and implementing a portion of the HUD CDBG programs to the States, whereby programs could be developed to serve the low and moderate income persons, not only at the large City level, but also at the Small City and Village level, which reached into the areas showing significant decline in the condition of the local housing stock, infrastructure and employment, issues which are so vital to the sustainability, stabilization, and revitalization of the country's most significant assets, and;

WHEREAS, the Home Investment Partnership Act was passed, which supplemented funding to further carry out the Housing Strategies in communities of the greatest need, providing benefits to families and local neighborhoods, in addition to providing jobs for local contractors and suppliers, who are a significant part of the fabric of the American Society, and;

WHEREAS, the United States of America is in a position now where it cannot cause further decline in the make-up of our economic and social-community values, whereby leading to more serious health and safety issues, as a result of climinating programs which have been so remarkably successful at the household level, improving the living conditions of the neighborhoods, and continuing to achieve the American dream; and

WHEREAS, the sustainable funding level necessary to complete and continue the Community Housing Improvement and Community Investment Strategies developed for every small City and Entitlement City in the United States of America, must be similar to

the FY 2011 HUD budgets, and should not be more than a five percent (5 %) reduction from the FY 2011 level; and

WHEREAS, the local communities in the United States of America are urging that the Members of Congress judiciously keep in mind what the immediate ramifications of severe cuts in the CDBG and HOME programs will be regarding existing and new jobs, services provided to local households, contractor and supplier unemployment, declining neighborhoods, safety, fear of crime, and other social and community values, realizing Congress just can't wipe out successful programs without having an immediate replacement program, which is designed to continuously return tax dollars back to their communities, and to the people who pay their salaries.

NOW, THEREFORE BE IT RESOLVED, by the Board of the Brown County Commissioners to pass this resolution this 2^{Rd} day of November, 2011.
