I'm bringing forward a motion to relieve 911 Director Rob Wilson of his duties as director of 911 operations immediately due to the following reasons on Nov 21, 2011 at Brown County Board of Commissioners Office with the following commissioners present Rick Eagan, Bill Geschwind and Ralph Jennings a public records request was given to you by Sheriff Dwayne Wenninger in order to clear up some issues between his office and local police agencies.

Conversation between Dispatcher Nowana Bingaman and Lt. John Fetters
Conversation between Dispatcher Nowana Bingaman and Chief Deputy John Schadle
Conversation between Dispatcher Nowana Bingaman and Rob Wilson

You stated to Sheriff Wenninger that the conversations between Dispatcher Nowana Bingaman and Lt. John Fetters and the conversation between Dispatcher Nowana Bingaman and Chief Deputy John Schadle didn't exist because you have searched for them to listen to. They called in on Dispatcher Bingaman cell phone to talk to her. Having a cell phone in the 911 operations violates your own protocol. In an email sent to your Supervisors dated August 19, 2011 you address the use of cell phones. When you determined there might be a criminal investigation on tampering with public records you came forward on Nov 30, 2011. You came forward and advised the County Commissioners that you had found the missing conversations and stated you had over looked them. In another issue advised Sheriff Wenninger that you was unaware of a mutual aide contract between the Villages, OSP and the Brown County Sheriff's Dept until I personally gave you a copy on Nov 17, 2011 and the Brown County Prosecutor advised the board of commissioners on Nov 30, 2011 that you had asked for mutual aide contract understanding two weeks earlier and on the same issue you admitted that you had changed Dispatcher protocol on wed Nov 16, 2011 and didn't read the mutual aide agreement until Brown County Chief Deputy John Schadle confronted you on Sat Nov 19, 2011 and then you changed back to the original protocol and admitted that Chief Deputy Schadle was right. Your conduct in my opinion greatly jeopardizes the integrality of the Operations of the 911 Communications Center.
