The County agrees to assume and bear one hundred percent (100%) of the entire cost of the improvement, less the amount of Federal-aid CEAO funds set aside by the Director of Transportation from funds allocated by the Federal Highway Administration, U.S. Department of Transportation for the financing of this improvement, and further, the County agrees to assume and bear one hundred percent (100%) of the Preliminary Engineering and Right-of-Way, excluding in-house preliminary engineering and right of way charges incurred by the State.
